Subject: Annual HUD Grant Renewals for Continuum of Care (CoC) Programs

BACKGROUND:

The U.S. Department of Housing and Urban Development (HUD) offers permanent, supportive housing to persons experiencing homelessness as well as services including health care and mental health counseling. On behalf of Indian River County, grant applications are submitted by Treasure Coast Homeless Services Council, Inc. (TCHSC) for funding of these services. Once awarded, TCHSC administers the grant funds for Continuum of Care (CoC) programs in cooperation with the Human Services Department of Indian River County and the State Health Department.

Below is a list of nine grants awarded to Indian River County which are renewing in 2022.
