It is respectfully requested that the information contained herein be given formal consideration by the District Board of Commissioners at the next scheduled meeting.

BACKGROUND

Indian River County Fire Rescue was allotted \$245,000.00 in the approved FY 21/22 budget for the purchase of a Brush Truck. Staff is requesting this funding be reallocated towards the purchase of a Heavy Rescue Apparatus. This apparatus will allow Fire Rescue to respond as an "All Hazards Special Operations" (High Angle Rescue, Vehicle Extrication, Confined Space Rescue etc.) as one unit.

DESCRIPTIONS AND CONDITIONS

Staff has recently been made aware of the availability of a 2016 International 4400 Commercial Walk-In Rescue Truck by Brindlee Mountain Fire Apparatus. This apparatus has a list price of \$225,000.00 however after negotiation they have agreed to a sale price of \$215,000.00. The cost of a brand new apparatus of this nature is \$385,000.00, with a build time of 20 months. The apparatus available is already equipped with all the necessary equipment to be put into service almost immediately, with the exception of tag, title, insurance and decals. The apparatus has 5,071 miles on the odometer and offers additional appurtenances such as an onboard generator, electrical lines, multiple scene lights, emergency lighting, a 1-year dealer warranty, a full service of the vehicle prior to delivery and free delivery of the apparatus.
