**DESCRIPTION AND CONDITIONS**

County staff has identified the need for extending the eastbound to southbound right turn lane at CR-510 and 66<sup>th</sup> Avenue. Indian River County Engineering evaluated conditions for possible improvements at the intersection of CR510 and 66<sup>th</sup> Avenue during the 3<sup>rd</sup> quarter of 2017.

Since that time, Indian River County Engineering has completed construction documents for bidding. A bid opening for the project was held on April 11, 2018. Three (3) qualified bids were received and opened. A detailed bid tabulation is on file and available for viewing in the County Engineering Division. Bid totals are as follow:

Mancil's Tractor Service, Inc. is considered to be the lowest, responsive, responsible bidder for the project with a bid totaling \$151,016.30. Mancil's Tractor Service, Inc. has successfully completed roadway intersection improvement construction projects within the State of Florida for local municipalities and the Florida Department of Transportation. The Mancil's Tractor Service, Inc. bid was below the Engineer's Estimate of \$155,684.60.

**FUNDING**
