## **BACKGROUND:**

On behalf of the Road and Bridge Division, annual bids were requested for contractors to perform mowing in six roadway right-of-way sections. This is a new bid, with term of award proposed to be one year, with the option of two one-year extensions, subject to satisfactory performance, vendor acceptance, and the determination that renewal of this annual bid is in the best interest of Indian River County.

#### **ANALYSIS:**

The invitation to bid noted that each section will be awarded in its entirety, with Contractors eligible to be awarded one or more sections. The bid documents also provided that the County reserves the right to award the work a manner that is in its best interest. Therefore, the department reviewed the bids and proposed distribution of the work among four contractors. The instances where the lowest bid is not recommended for award reflect a lack of evidence provided by the low bidder of sufficient staff and equipment to perform work in more than one Section. The annual bid totals for each of the six sections and staff's recommended award are shown on the table on the next page.

## **RECOMMENDATION:**

Staff recommends the Board award Bid 2022029 to Juniper Landscaping of Florida, LLC (Sections 1 and 6), Brightview Landscape Services, Inc. (Section 2), Jeffery Hogues Lawncare (Section 3), and Kerner Environmental (Sections 4 and 5), and authorize the Purchasing Division to issue blanket purchase orders with the selected contractors. Staff also recommends the Board authorize the Purchasing Manager to renew this bid at the same rates for two (2) additional one (1) year periods subject to satisfactory performance, vendor acceptance, and the determination that renewal of this annual bid is in the best interest of Indian River County.
