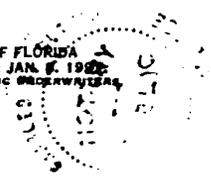

3. The land referred to in this policy or guarantee is described as follows:

The Northern 5 acres of that portion of Government Lot 3, lying South of Gifford Dock Road in Section 24, Township 32 South, Range 39 East, Indian River County, Florida, being more particularly described as follows: Commence at the Southwest corner of Government Lot 3, Section 24, Township 32 South, Range 39 East, said point being in the South 1/4 corner of said Section 24; thence North 00° 04' 13" West along the West line of said Government Lot 3, 665.74 feet to the Point of Beginning of the herein described parcel; thence North 60° 21' 52" East 748.65 feet to a point on the survey control line; thence South 17° 09' 57" East, 370.00 feet along said survey control line; thence South 72° 52' 52" West, 794.87 feet to a point on the West line of said Government Lot 3; thence North 00° 04' 13" West, 217.30 feet to the Point of Beginning. The herein described parcel of land contains 5.00 acres, more or less, to the survey control line.

Exhibit "A"

Subject to a 30 foot wide Ingress/Egress Easement described as follows;

Commence at the Southwest corner of Government Lot 3, Section 24, Township 32 South, Range 39 East; Thence, run North 00 Degrees 04 Minutes 13 Seconds West along the West line of said Government Lot 3 for a distance of 631.25 feet; Thence, run North 60 Degrees 21 Minutes 52 Seconds for a distance of 389.09 feet to the Point of Beginning. Thence, run South 15 Degrees 26 Minutes 10 Seconds East for a distance of 259.00 feet; Thence, run North 72 Degrees 52 Minutes 52 Seconds East for a distance of 30.01 feet; Thence, run North 15 Degrees 26 Minutes 10 Seconds West for a distance of 265.71 feet; Thence, run South 60 Degrees 21 Minutes 52 Seconds East for a distance of 30.95 feet to the Point of Beginning.
