

The opioid crisis continues to impact Indian River County at alarming rates. Through this RFA process, we sought to identify providers capable of delivering evidence-based, recovery-oriented solutions that address both immediate needs and long-term sustainability. Today, we present the results of a rigorous evaluation process and our recommendations for funding under the Florida Opioid Settlement Agreement.

1. Summary of the RFA Process

- **Purpose:** The RFA was issued by Southeast Florida Behavioral Health Network (SEFBHN) under the Florida Opioid Settlement Agreement to fund evidence-based opioid abatement initiatives in Indian River County.
- **Goals:** Address gaps identified in the Thrive IRC Needs Assessment, including:
 - High opioid-related deaths
 - Limited access to detox and residential treatment
 - Barriers such as transportation, childcare, and housing
- **Priority Areas:**
 - Public awareness and stigma reduction
 - Expanded access to treatment and recovery services
 - Jail-to-community transitions
 - Peer support workforce development
- **Approved Uses:** Treatment, prevention, harm reduction, criminal justice interventions, services for families, and workforce development.

Timeline Highlights:

2. Scoring Process

- **Phase I – Written Applications**
 - Maximum: 525 points
 - Threshold: 420 points to advance
 - Criteria included:
 - Scope of Work (70 pts)
 - Staffing (50 pts)
 - Performance Measures (40 pts)
 - Budget Narrative (60 pts)
 - Recovery-Oriented System of Care, Licenses, Letters of Support, etc.
 - **Phase II – Oral Presentations**
 - Evaluated by Indian River County Opioid Taskforce Committee
 - Scored on clarity, comprehensiveness, innovation, and organizational capacity
 - **Final Score:** Combined average of written and oral scores

3. Introduction to Recommendations

- **Selection Basis:** Highest cumulative scores, alignment with county priorities, and capacity to implement quickly.
- **Recommended Providers:**
 - Thrive - Centralized intake and referral system, Respite
 - Treasure Coast Community Health – Mobile MAT Services at Thrive
 - Treasure Coast Homeless Services Council – Housing assistance and Case Mgmt.

- New Horizons of the Treasure Coast – Detox Bed at NHTC Main Unit
 - Ritelife Services – Peer Training and Apprenticeship
 - **Funding Terms:** Initial 12-month contract (April 2026–March 2027)
