- Provide engineered permit drawings confirming capacity of existing chillers only.
- Directional bore 4" SDR 17 HDPE piping under parking lot from existing chiller yard to Health Dept. Building.
- Perform shutdown to connect HDPE piping to existing chiller yard and Health Dept. building. Install 4" secondary taps.
- Insulate to match existing. Backfill and compact excavation.
- Remove existing Trane 100 ton air cooled chiller and associated piping. Provide crane lift, disposal of chiller and safe off electrical disconnect from chiller once removed.

**EXCLUSIONS:**

- Building code upgrades that may be required, bonding, patch/plaster/painting, plumbing, general contracting services, fire alarm and/or protection services, controls, landscaping or any item/services not expressly mentioned above.

**WARRANTY:**

- Manufacturer's limited materials warranty as applicable.
