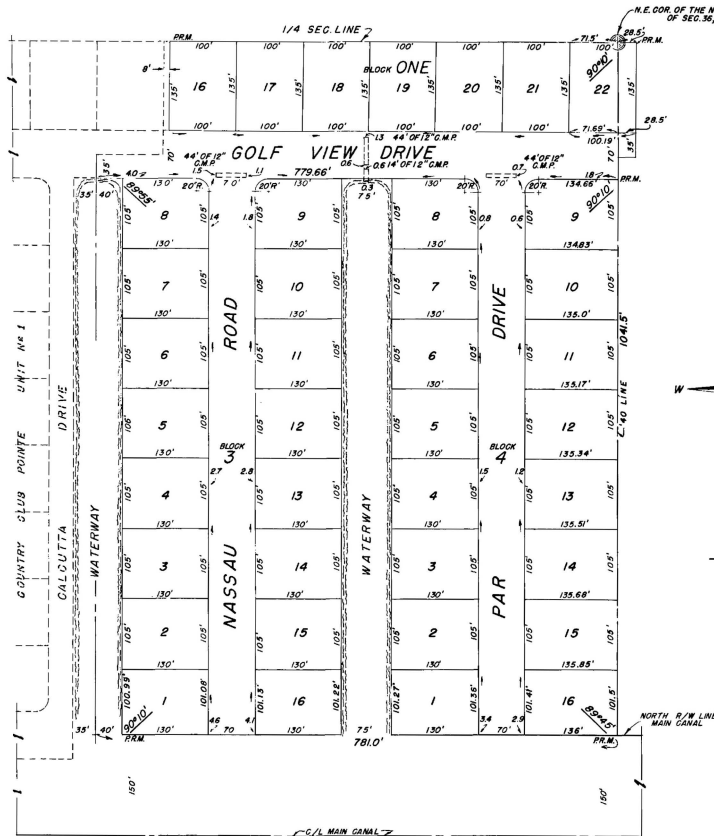


COUNTRY CLUB POINTE
