



**LEGAL DESCRIPTION**

ALL OF THOSE LANDS DESCRIBED IN OFFICIAL RECORD BOOK 2697, PAGE 311 OF THE PUBLIC RECORDS OF INDIAN RIVER COUNTY FLORIDA, LESS AND EXCEPT THE FOLLOWING DESCRIBED PARCEL:

BEGIN AT THE INTERSECTION OF THE WEST LINE OF TRACT 15, SECTION 33, TOWNSHIP 32 SOUTH, RANGE 39 EAST, INDIAN RIVER COUNTY, FLORIDA, AND THE EXISTING NORTH RIGHT-OF-WAY LINE OF 26TH STREET (WALKER AVENUE, 45-FOOT RIGHT-OF-WAY) AND RUN NORTHERLY, ALONG SAID WEST LINE OF TRACT 15, A DISTANCE OF 35 FEET TO A POINT; THENCE, LEAVING SAID WEST LINE OF TRACT 15, RUN EASTERLY, 80 FEET NORTH OF AND PARALLEL WITH THE SOUTH LINE OF SAID SECTION 33, A DISTANCE OF 109.3 FEET TO A POINT LYING 25 FEET WEST OF THE EAST LINE OF THE WEST 134.3 FEET OF SAID TRACT 15; THENCE RUN NORTHEASTERLY A DISTANCE OF 35.5 FEET, MORE OR LESS, TO A POINT ON SAID EAST LINE OF THE WEST 134.3 FEET OF TRACT 15, SAID POINT LYING 105 FEET NORTH OF THE SOUTH LINE OF SAID SECTION 33; THENCE RUN SOUTHERLY, ALONG SAID EAST LINE OF THE WEST 134.5 FEET OF TRACT 15, A DISTANCE OF 60 FEET TO A POINT ON SAID EXISTING NORTH RIGHT-OF-WAY LINE OF 26TH STREET; THENCE RUN WESTERLY, ALONG SAID EXISTING NORTH RIGHT-OF-WAY LINE, A DISTANCE OF 134.3 FEET TO THE POINT OF BEGINNING.
