On behalf of the Parks, Recreation and Conservation Department, sealed bids were solicited for replacing the existing wooden decking, railings, benches and fish cleaning table on the T-Dock, located within Donald MacDonald Campground. Bids for standard decking were requested as well as ones for Fibergrate MicroMesh Decking.

RECOMMENDATION:
