Florida Statute 932.7055, the Florida Contraband Forfeiture Act, provides that proceeds and interest earned from the forfeiture of real or personal property shall be used for providing additional equipment and may not be used to meet normal operating expenses of the law enforcement agency. These funds are the direct result of our deputies' diligent law enforcement efforts and are derived mainly from drug related offenses. None of the funds are derived from county tax dollars.

Please consider this letter as a request for transfer of \$25,035.45 to the Indian River County Sheriff's Office. These funds will be used to purchase required aviation survival equipment, video capture kit for helicopter flashback system, and a video capture system for interview room.
