W I T N E S S E T H :

That COUNTY, for and in consideration of the sum of \$125,000 to it in hand paid by TOWN, receipt whereof is hereby acknowledged, and the TOWN giving the COUNTY title to certain land in Gifford, has granted, bargained, and sold to TOWN, its heirs and assigns forever, the following described land lying and being in Indian River County, Florida:

This conveyance is made subject to the following RESTRICTION:

The County has the right-of-first refusal if the Town ever decides to sell or otherwise dispose of the property transferred by this Deed. Any such proposed sale or disposal shall be offered by the Town to the County in writing, and the County shall have 90 days within which to accept the offer or not.
