SUBJECT: Agreement with Sun Patrick Architecture, DBA: sparcdesign for Sandridge

Clubhouse Architectural Design (RFQ 2021020) – Master Planning Phase

BACKGROUND:

On June 15, 2021, the Board approved the final ranking of consultants and authorized negotiations for architectural design services for the expansion of current clubhouse facilities at Sandridge Golf Club, in accordance with Section 287.055, Florida Statute (Consultant's Competitive Negotiation Act, or "CCNA"). The existing single-story clubhouse opened in December of 1992 and consists of a café, pro shop, bathrooms and staff offices. The intent of the project is to design a new facility, which will provide the existing amenities, and include event space and a commercial grade kitchen.

ANALYSIS:

Negotiations with the top ranked firm, Sun Patrick Architecture, DBA: sparcdesign, have been completed, and both parties are ready to begin the master planning phase of the project, for a fixed not to exceed fee of \$25,000, plus reimbursable expenses such as mileage.

Because much of the actual design work will be a result of the master planning phase, a final total cost to design is not yet available. An estimate for the total project design cost is provided in the table below.

A separate agreement for the second phase of the project will be brought to the Board after the master plan has been completed. This phase will include design development, construction documents, bidding assistance and construction administration.

FUNDING:

Funding for the Clubhouse Architectural Design project is budgeted and available in the Sandridge Clubhouse and Event Space account (418-169000-21018).

RECOMMENDATION:

Staff recommends the Board approve the Agreement for Professional Services for the Master Planning Phase, and authorize the Chairman to sign after approval by the County attorney as to form and legal sufficiency.
