WHEREAS, Lori performed food safety inspections as a Sanitation and Safety Specialist, and quickly found her place in the expanding onsite sewage disposal and treatment system (OSTDS) program; and

WHEREAS, Lori's organizational and prioritization skills, creative problem solving, regulatory knowledge, proficiency, dependability, utmost professionalism, and conscientious attitude towards customer service are key to the local success of the OSTDS program where Lori was promoted to an Environmental Specialist II; and

WHEREAS, Lori has been a Registered Sanitarian credentialed through the Florida Environmental Health Association since June 16, 1997; and

WHEREAS, Lori accepted an appointment by Dr. Richard Hunter to the Environmental Health Professional's Advisory Board on June 28, 2000, serving on the board until October 1, 2018; and

WHEREAS, Lori improved program and service delivery effectiveness and consistency, advised co-workers, contractors, and the public in an approachable manner, administered everchanging regulations with thoughtful understanding and kindness, and willingly shared her knowledge as the program coordinator recognizing the importance of a team effort; and

WHEREAS, Lori's responsibilities included permit and project application reviews, OSTDS permitting, site evaluations, site inspections, complaint investigations, operating and/or service permitting and inspections, activity documentation into the Environmental Health Database (25,729 entries), as well as coordinating and reviewing work done by co-workers; and

WHEREAS, Lori is respected by co-workers, local contractors, engineers, attorneys, developers, building departments, utility departments, and community development agencies.
