Subject:	Jake Owen Foundation's Request to Utilize Sampson Field to Support Charity Event On December 9, 2016

### **BACKGROUND:**

The Jake Owen Foundation is requesting permission to utilize Samson Field at the 16<sup>th</sup> Street Ballfield Complex in support of a charity event scheduled for December 9, 2016. The event is known as the 10<sup>th</sup> Annual Jake Owen Foundation Benefit Concert – A Jake Owen Intimate Performance at the Vero Beach High School Performing Arts Center. Prior to the performance, the event organizers plan to invite approximately 150 guests to a VIP Reception under a tent at Sampson Field. The request includes use of the grounds, ballfield lights, and permission to serve alcohol from 4:30 p.m. to dusk. Although County Code Section 205.03 generally prohibits the consumption of alcohol at recreational facilities, the limited use presented by this special event seems appropriate for waiver. The applicant has agreed to comply with County Code Section 205.09(1) which sets forth criteria for permitting the consumption of alcohol at other designated venues throughout the County provided that:

- (a) The applicant holds all required state alcoholic beverage licenses;
- (b) The applicant has made adequate plans, and is ready, willing and able to implement such plans, for security or police presence;
- (c) The applicant has obtained liability and any other insurance required by the county risk manager, and has provided certificates evidencing such insurance, in amounts and all other respects acceptable to the county risk manager;
- (d) The applicant has met all other conditions determined by the department to be necessary to protect the health, safety and welfare of the residents of Indian River County, in light of the planned event or activity; and
- (e) The applicant has paid the required fee as established by the department.

The Foundation has submitted a written request, which is attached. The details of the request demonstrate an intent to comply with the criteria set forth above; however, given the nature of the charitable cause, a waiver of the nominal fees for field usage and lights appears reasonable.

# **RECOMMENDATION:**

Staff respectfully recommends that the Board authorise the Indian River County Parks Division to issue the permit herein requested, waive any field and light rental charge, and waive the alchohol consumption prohibition under County Code Section 205.03 for the Event.
