A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF INDIAN RIVER COUNTY, FLORIDA, AMENDING THE DEPARTMENT OF UTILITY SERVICES' SCHEDULE OF WATER AND SEWER RATES, FEES AND OTHER CHARGES, BY AMENDING THE SLUDGE AND SEPTAGE RATES.

WHEREAS, the Board desires to further amend the Schedule, as set forth herein;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF INDIAN RIVER COUNTY, FLORIDA, THAT:

- 1. <u>Findings</u>. The above "whereas" clauses are adopted as the findings of the Board, and are incorporated herein.
- 2. <u>Amendment to Schedule of Rates, Fees and Charges</u>. The Board hereby amends the Department of Utility Services' Schedule of Water and Sewer Rates, Fees and Other Charges, by amending the following rates, fees and other charges, which shall go into effect upon execution of this resolution:

Sludge and Septage Rates (b)

Charge Per 1,000 Gallons (a) \$30.8262.55
Charge Per Wet ton (b) \$7.51 15.00
One Time Dump Fee for Recreational Vehicles – Per Dump \$10.00

3. Rates, Fees and Other Charges Not Amended to Remain in Full Force and Effect. In all other respects, the Department of Utility Services' Schedule of Water and Sewer Rates, Fees and Other Charges shall remain in full force and effect.
