RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF INDIAN RIVER COUNTY, FLORIDA, PROVIDING FOR THE VACATION OF HIDEAWAY COVE SUBDIVISION, PLAT BOOK 10, PAGE 60, INDIAN RIVER COUNTY, SAID LAND LYING AND BEING IN INDIAN RIVER COUNTY, FLORIDA

WHEREAS, on September 13, 2017, Indian River County received a duly executed and documented application from Ocean Trail, LLC requesting that the County vacate the plat of Hideaway Cove Subdivision recorded in Plat Book 10, Page 60 of Indian River County, Florida, said land lying and being in Indian River County, Florida; and

WHEREAS, in accordance with Florida Statutes 177.101, notice of the intent to apply for plat vacation was duly published by Ocean Tail, LLC in two weekly issues of a newspaper of general circulation in the County; and

WHEREAS, after consideration of the petition, supporting documents, staff investigation and report, and testimony of all those interested and present, the Board finds that Ocean Trail, LLC owns the fee simple title to all lands within the Hideaway Cove Subdivision; and

WHEREAS, the Board further finds that vacation of the subdivision plat will not affect the ownership or right of convenient access of persons owning other parts of the subdivision.




