- 1. The above recitals are true and correct and are adopted by reference herein.
- The term of the Memorandum of Understanding for Coordination of Supplemental Beach Nourishment and Related Coastal Activities dated April 2, 2013 is hereby renewed and extended until April 1, 2023, nunc pro tunc.
