## AGREEMENT

THIS AGREEMENT, entered into this <u>llth</u> day of <u>April</u>, 1989, by and between the BOARD OF COUNTY COMMIS-SIONERS OF INDIAN RIVER COUNTY, FLORIDA, 1840 25th Street, Vero Beach, Florida 32960 (COUNTY), and FIRST BAPTIST CHURCH OF VERO BEACH, INC., a Florida nonprofit corporation, 2206 16th Avenue, Vero Beach, Florida 32960 (CHURCH),

## WITNESSETH:

That for and in consideration of the mutual covenants contained in this Agreement, the COUNTY and the CHURCH agree as follows:

 The COUNTY and the CHURCH will jointly utilize property described as:

Lots 4, 5, 6, 7 and 8, Block 28, City of Vero Beach Subdivision, as recorded in Plat Book 2, Page 12, Public Records of Indian River County, Florida,

which lots are owned by the CHURCH, as a parking lot. The COUNTY will normally utilize the above parking lot during the daylight hours during the week, and CHURCH will normally utilize the parking area all day Sunday and on Wednesday nights, but each party will have the right to use the property for parking at all times. This agreement shall run with the land during the term of this agreement.

2. In return for the use by the COUNTY of this parking lot, the COUNTY agrees to plan, construct and pay for improving, constructing and maintaining the parking lot for the joint use of both parties. Plans, construction and costs must first be approved in writing by the CHURCH.

3. The COUNTY and CHURCH will jointly promulgate reasonable rules and regulations of the parking area.

4. The COUNTY and the CHURCH shall jointly utilize the above property for parking for an indefinite term of years from the date of this agreement.

5. If during the lease term, the CHURCH desires to construct a building on the property or otherwise utilize the

property for its sole use, then, in that event, the CHURCH may cancel this lease by giving the COUNTY and the CITY OF VERO BEACH at least twelve (12) months' written notice, and if the termination occurs during the first ten years of this lease agreement, the COUNTY shall be reimbursed as follows:

Reimbursement =

1 - (Number of years utilized by County) x Construction Cost ( 10-Year design life )

Any termination after ten (10) years shall require no reimbursement.

6. The COUNTY agrees to hold the CHURCH harmless from any and all claims for damages which may occur as a result of the use by the COUNTY of this parking lot during the time the public is allowed to use the lot, except for claims which arise out of the sole negligence on the part of the CHURCH. The COUNTY agrees to include the Church as additional insured for all liability for damages for any occurrence on the property.

7. This lease shall be recorded.
