Dear Chairman Flescher and County Commissioners:

We are pleased to remit \$592,379.60 in excess fees to Indian River County. This represents 38.9% of the funds provided by the Board to the Clerk of Court and Comptroller for the 2024-2025 fiscal year. The return of these funds are possible due to unspent funds in the Board's approved budget for the Comptroller and Clerk to the Board divisions and excess fees from the Official Records Division, which is funded by user fees. I am pleased to return this amount which, combined with the prior four years of excess fees, exceeds \$2,100,000 returned to the Board over that time. The dedicated staff at the Clerk and Comptroller's Office deserve the credit for responsibly managing the county's resources.

I would like to take this opportunity to thank the Board and County Administration for their assistance, support and leadership.
