We would like to begin by expressing our sincere appreciation for our partnership with CSAC and our shared commitment to supporting community-wide prevention initiatives. We are grateful for the opportunity to have collaborated on the Trauma Informed Care (TIC) program and to contribute to the well-being of children and families in Indian River County.

While we believe this program has been important and impactful, we understand that it no longer aligns with CSAC's priorities moving forward. Despite our efforts, we have been unsuccessful in securing alternative funding outside of CSAC. After careful consideration, we have decided to conclude the Trauma Informed Care (TIC) program at the end of Q3 and will not be billing CSAC beyond that point. This decision reflects our evolving organizational priorities and the need to focus our resources on expanding outpatient mental health services in response to the closure of Suncoast Mental Health Center.

We will ensure our Q3 report is completed as well as ensuring a smooth and respectful closeout of the program. Dr. Brooke Hall will no longer serve in a dual capacity, and we will not seek reimbursement for her time under this grant for the remainder of the term.

We also want to acknowledge and apologize for the billing error that occurred in April in which 80 hours (\$3,128.41) was inadvertently charged to both IRHD and CSAC. As previously communicated, this was a one-time oversight that was promptly corrected. We appreciate your understanding and remain confident in the strength of our internal controls.

While this marks the conclusion of the TIC initiative, we hope to continue working together to address the critical mental health needs of children in our community. We remain the only organization currently seeking support specifically for children's mental health, and we believe this work is more important than ever.
