Dear Chairman Flescher:

I am enclosing the 2024 Excess Fee Report of the Indian River County Tax Collector's Office.

Total income for fees from all sources and investment income for 2024 was \$9,871,647 a difference of \$610,227 over projected income; total expenditures were \$6,586,067 which is \$179,835 under projected expenditures. The excess fees were \$3,285,580 an increase over projected excess fees of \$790,062. This breaks down to \$3,043,583 being returned to the Board of County Commissioners, an increase of \$731,871 from our projected amount, and \$241,997 being returned to the other taxing districts.
