## The Issue: 2021 NSDUH Data



of people aged 12 and older with a Substance Use Disorder did not receive treatment.

#### Reasons for not receiving treatment:

- No health care coverage and not being able to afford the cost of treatment
- Not knowing where to go for treatment
- Not being able to find a program that offered the type of treatment they wanted
- They could handle the problem without treatment
- Concerned that getting treatment might have a negative effect on their job

## Substance Use Needs Assessment

Goal: Understand the unique needs of Indian River County and persons most impacted by the opioid crisis.

Areas of Focus:

- Comprehensive data analysis
- Key Informant/Focus Group Interviews with those directly impacted by the opioid epidemic
- Update the Sequential Intercept Mapping done by USF in 2018
- Strategic planning meeting to strengthen the system of care in IRC from prevention to recovery.



Estimated Cost: \$35,000 to 50,000 Quote provided by CARE Team



## **Jail Treatment Program**

#### Goal: Reduce the Impact of Substance Use Disorder

- Estimated 65% of the United States jail/prison population has an active Substance Use Disorder.
- Lack of treatment services in jail was identified as a gap on the 2018 Sequential Intercept Mapping

#### **Recommendation:**

- Intensive jail-based treatment program
   (DCF License IOP or Day Treatment 9-16 hours of services per week)
- Include MAT services in collaboration with TCCH
- Data from current SAC programming highlights need to expand services.
- Several comments from May-August 2023 cohorts expressed wanting longer sessions and more services.

## Mobile Outreach Van

#### Goal: Reduce barriers and increase access to services.

- Mobile Outreach Vans are an effective tool to engage hard to reach populations
- Can provide variety of services related to substance use treatment and prevention.
- Service suggestions for a Mobile Outreach Van in Indian River County:
  - Mobile urine collections
  - Overdose education including Narcan dissemination
  - Screening and referrals for Treatment
  - Peer Outreach and Support





## **Training**

#### Goal: Reduce stigma and increase knowledge about SUD

Stigma can have a significant impact individuals with SUD

- Can reduce willingness for persons with SUD to seek treatment
- Can also impact care provided by health care providers

#### **Recommendation:**

- Form task force or committee
- Create a training plan to meet community needs
  - Focus on training for healthcare providers, businesses, law enforcement, and the judicial system.



## **Expanding SAC Treatment and Prevention**

### Goal: Reduce the Impact of Substance Use Disorder

- Provides treatment and prevention services in Indian River County since 1989.
- Provides services regardless of ability to pay.
  - Treatment clients pay an average of \$3 a visit.
- All programs offered under Prevention Works! and Recovery Works!
   are acceptable uses of Settlement Funds.
- Current capacity is limited due to lack of space.
- Additional funding can increase the capacity of Substance Awareness
  Center to provide treatment and prevention services to Indian River
  County.
