SUBJECT: County Capital Asset Inventories

Annual physical inventories of capital assets are conducted for all Board departments as well as the Clerk of the Circuit Court & Comptroller, Property Appraiser, Supervisor of Elections, and Tax Collector. Per Florida Statute 274.02, the Comptroller Division has completed a detailed physical inventory of approximately 3,500 assets with a current book value of \$44,890,599. Assets to be removed from the inventory must be presented to the Board for approval per Florida Statute 274.07. Two lists have been attached. The first list contains items that need to be removed as they were not located during the physical inventories. The second list contains items that need to be deleted due to reasons other than prior approval for surplus by the Board. The reasons for deletion include assets that were removed by vendors as part of the installation of new assets, demolition of buildings, and replacement of software among others. The reason for each asset removal is detailed on the list.

Recommendation:

Staff recommends approval to remove the listed assets from the inventory system.
