

## **SECOND EXTENSION TO AGREEMENT FOR ANNUAL SEWER SERVICES**

This Second Extension to that certain Agreement to provide Annual Sewer Services is entered into effective as of July 17, 2024, by and between Indian River County, a political subdivision of the State of Florida ("County") and Meeks Plumbing, Inc. ("Contractor").

### **BACKGROUND RECITALS**

**WHEREAS**, the County and the Contractor entered into an Agreement for Annual Sewer Services effective July 7, 2020; and

**WHEREAS**, Paragraph 3 of the Agreement contains the term and renewal provisions; and

**WHEREAS**, the first term commenced effective as of July 17, 2020 and ended on July 16, 2023; and

**WHEREAS**, the first renewal term commenced effective as of July 17, 2023 and will end on July 16, 2024; and

**WHEREAS**, pursuant to the Agreement, the parties desire to extend the Agreement for an additional one year; and

**NOW, THEREFORE**, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and the Contractor agree as follows:

1. The background recitals are true and correct and form a material part of this Second Extension.
2. The Second renewal term shall commence effective July 17, 2024, and shall end on July 16, 2025.  
This is the final extension available on the contract.
3. All other terms and provisions of the Agreement shall be unchanged and remain in full force and effect.
