County Administrator John Titkanich announced that the total proposed budget for Fiscal Year (FY) 2024/2025 was \$524,719,875, an increase of \$17,818,335 over last year's planned budget. He utilized a PowerPoint presentation to highlight the major impacts to the proposed budget noting a tax roll increase of 10.3% countywide and 10.0% in the unincorporated areas. He stated it was the initial year of the Environmentally Sensitive Land Acquisition Bond, Series 2024 millage levy of 0.0639, and pointed out that the FY 2024/2025 budget reflects the County's priority commitment to public safety, noting \$145.7 million was allocated to law enforcement,

emergency services, and fire rescue. He added an agreed-to Sheriff's Office funding of \$4.78 million (a reduction from the initial request of \$8.84 from the current budget), continued funding of School Resource Officers at a 50% split with the School District, the Compensation Study implementation cost of \$8,686,151, increases in the retirement rate (not including Constitutional Officers), and Worker's Compensation (including Constitutional Officers), and an increase of 38.9 full-time positions.

5. AD VALOREM FUNDS

A. Ad Valorem Millage and Ad Valorem Budget

Mr. Lance Lunceford, President of the Taxpayers' Association of Indian River County (Taxpayers' Association), stated the FY 2024/2025 Budget carried the Taxpayers' Association's full support. He thanked the Board and staff for their continued collaboration with the Taxpayers' Association.
