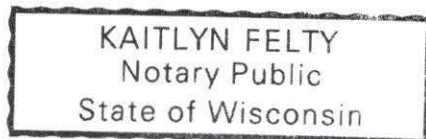

**AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF INDIAN RIVER COUNTY, FLORIDA, AMENDING SECTION 103.22 (APPOINTMENT TO THE CHILDREN'S SERVICES ADVISORY COMMITTEE) OF PART II (CHILDREN'S SERVICES ADVISORY COMMITTEE) OF CHAPTER 103 (COMMISSIONS AND BOARDS) TO UPDATE MEMBERSHIP REQUIREMENTS OF THE CHILDREN'S SERVICES ADVISORY COMMITTEE; AND PROVIDING FOR CODIFICATION, SEVERABILITY, REPEAL OF CONFLICTING PROVISIONS; AND AN EFFECTIVE DATE.**
